- **Can I make a gift that is anonymous?**

Yes, any contribution may be gifted anonymously. When making your gift, please indicate you want your gift to be anonymous.

- **Is my gift tax-deductible?**

Yes. Black River Memorial Hospital, Gifts of Gratitude, is a nonprofit 501 (c)(3) charitable organization. All gifts are tax deductible to the full extent of the law. For your convenience, we will supply a tax letter in January with the previous year's cumulative contributions.
